

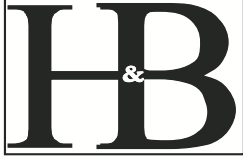

May: National Elder Law Month

On the final night of its 60-day session, the Florida Legislature delivered a Medicaid Reform Bill that will privatize the Medicaid Program statewide. The Medicaid Reform initiative has been in the works for several years, but the bill that finally passed was in circulation for less than 30 hours before the final vote.

The original version of the Medicaid Reform and other legislation included many provisions that we believe would have been very harmful to the vulnerable elderly population in Florida. In addition, other bills were also under consideration that would have greatly reduced the ability for elderly individuals to protect and preserve their assets, maintain independence and ensure security while confronting the concerns of aging, illness and possible nursing home placement. Fortunately, through the efforts of several statewide organizations including the Elder Law Joint Public Policy Task Force, currently Chaired by our very own Randy Bryan, most of those provisions did not pass. Some of the provisions that did not end up in the final legislation included:

- ◆ Restrictions on an elder's ability to use their funds to pay a family member to provide for their care through a "personal service contract."
- ◆ Eliminating the ability for a spouse to protect and preserve their individual assets when the other requires long-term nursing home care, even in later in life marriages with valid prenuptial agreements.
- ◆ A cap on total Medicaid spending, which could have resulted in a reduction/elimination of benefits if a lapse in Florida's economic recovery or other unforeseen event had caused Medicaid enrollment to rise mid-year.
- ◆ Florida's threat of refusing to participate in the federal Medicaid Program (and the \$12 billion dollars a year in federal funding that comes with it) if the federal government didn't approve Florida's proposed Medicaid Reform initiatives by December. The loss of federal funding would have been devastating to the most vulnerable among us who rely on Medicaid as their medical safety net.

Despite the removal of these harmful provisions, several provisions remain that may still put vulnerable Floridians at increased risk. In short, the new system takes Medicaid out of the hands of...
