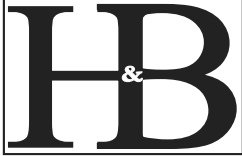

**Grilled Asparagus and Fennel  
Pasta Salad**

Want something different for the grill?  
Toss pasta with hot-off-the-grill veggies.

**Salad**

- 1 1/2 cups uncooked rainbow rotini pasta (about 5 ounces)
- 1/4 pound asparagus, cut into 2-inch pieces
- 1 medium fennel bulb, cut into thin wedges
- 1 small red onion, cut into thin wedges
- 2 teaspoons olive or vegetable oil, 1/4 teaspoon salt
- 1 small navel orange, peeled and coarsely chopped

**Vinaigrette**

2 tablespoons olive or vegetable oil, 3 tablespoons white balsamic vinegar, 1/4 teaspoon sugar, 1/8 teaspoon salt

1. Cook and drain pasta as directed on package.
2. Meanwhile, heat coals or gas grill for direct heat. Toss asparagus, fennel, onion, 2 teaspoons oil and 1/4 teaspoon salt until vegetables are coated. Place in grill basket. Grill 5 to 6 inches from medium heat 10 to 15 minutes, stirring vegetables frequently, until vegetables are crisp-tender. Cool slightly.
3. Shake all Vinaigrette ingredients in tightly covered container.
4. In large bowl, toss vegetables, pasta, orange and vinaigrette. Serve immediately, or cover and refrigerate up to 2 hours before serving.
